6. After School Sports

We know that it is disappointing that we are not offering after school sports this fall. The guidance requirements provided by MIAA the MA Interscholastic Athletic Association made our ability to provide a viable program for middle school students prohibitive. In addition, the changes we made to our school day schedule were necessary in order to meet our contractual obligations for providing teacher planning time. A downstream outcome is that students are dismissed from school at 1:45pm but faculty are not available to work with students until 2:55pm. The gap in time between dismissal and 2:55pm does not allow for after school athletics to take place in a manner that all students could access. Finally, if there are other middle schools available to compete against, we would need additional buses in order to meet the requirements for physically distancing students. We are not able to provide this level of transportation.

Finally, and most importantly, we have built our school day model on the premise that in order to keep our students and staff safe we need to do everything possible to maintain our small cohorts and minimize contact between individuals at school. We recognize that we cannot control what happens outside of the school day but we are asking for your help and support. At this time, we do not feel that providing after school athletics is the right decision. We will continue to monitor conditions and when the time is right, we will provide appropriate after school opportunities for students.
