1		KA SCHOOL/COMMUNITY RELATIONS GOALS	Propose adopting. Covers parents as well.
2		KBA SCHOOL-PARENT/GUARDIAN RELATIONS GOALS	Don't adopt - covered above
3		KBBA NON-CUSTODIAL PARENTS' RIGHTS	Propose adopting - but ask Parry and Rob if we follow this procedure. Don't think we need language around guardian here; this relates to custody issues.
4		KBE RELATIONS WITH PARENT/BOOSTER ORGANIZATIONS	Propose adopting. Current PTO groups would be grandfathered, no need to vote to approve them.
5	KCD Gifts/Donations/Grants to Schools	KCD PUBLIC GIFTS TO THE SCHOOLS	Propose adopting MASC for simplicity and covering grants, but keep first paragraph of Lincoln policy.
6		KDB PUBLIC'S RIGHT TO KNOW	Should adopt - but could we clarify that requests that are excessive or do not involve readily available information will not be addressed to the extent it creates resource constraints?
7		KDC COMMUNITY USE OF DIGITAL RESOURCES	Propose adopting.
8		KDCB. DISTRICT WEBSITE AND SOCIAL MEDIA	Propose adopting with minor clarifications.
9		KDD NEWS MEDIA RELATIONS/NEWS RELEASES	Propose adopting - good to clarify that the Superintendent should respond to media requests of a sensitive nature.

10		KE PUBLIC COMPLAINTS	Propose adopting MASC; add Lincoln KED statement about SC will only consider the matter if after review of the process carried out, it is determined that the administration failed to follow through adequately or did not follow a district policy or state or federal regulation or law. This covers policy KEC as well.
11	KEC Public Complaints About Curriculum or Instructional Materials		Propose rescinding - covered by KE and new policy IJ-R
12	KED Public Complaints About School Personnel		Propose rescinding - incorporated into MASC policy KE
13	KFB Use of School Buildings	KF COMMUNITY USE OF SCHOOL FACILITIES	HOLD. Possibly keep Lincoln, update coding to KF. Minor grammar updates.
14		KF-R COMMUNITY USE OF SCHOOL FACILITIES	HOLD.
15		KHA PUBLIC SOLICITATIONS IN THE SCHOOLS	Don't adopt - spirit is covered in Lincoln KHB.
16	KHB Advertising and Commercialism	KHB ADVERTISING IN THE SCHOOLS	Keep Lincoln
17	KBF Parent Visits to Classrooms (Coded KI in policy book)	KI VISITORS TO THE SCHOOLS	Adopt MASC, add parts of KBFA to bullet 5 about children's visits.
18	KBFA Policy on Children's Visits to Schools		Propose moving into KI and delete as a separate policy.
19		KLK RELATIONS WITH POLICE AUTHORITIES	Don't adopt; covered by policies regarding emergency plans, interrogations, and policy KLK.
20		KLJ RELATIONS WITH PLANNING AUTHORITIES	Don't adopt, but include last paragraph in KLK.
21		KLK RELATIONS WITH LOCAL GOVERNMENTAL AUTHORITIES	Adopt and include paragraph from KLJ.
