## School Building Committee Outreach Sub-Committee Meeting Friday, March 4, 2022 8:00am, Virtually

Virtual Meeting Pursuant to Governor Baker's March 12, 2020 Order Suspending Certain Provisions of Open Meeting Law

**Call to Order:** Kim Bodnar opened the meeting at 8:04am, noting that the Open Meeting Law requirement to have a quorum present in a physical location has been suspended due to the COVID-19 pandemic pursuant to Governor Baker's March 12, 2020 Order, as extended on June 15, 2021, with the Governor's signing of S.2475, suspending Certain Provisions of the Open Meeting Law. She confirmed that all participants were present and able to hear and see other participants.

Jennifer Glass began with a discussion about the dedication of the Harriet Todd Lecture Hall. Ms. Bodnar suggested that Harriet's family be invited to a private dedication and VIP tour of the auditorium prior to Town Meeting. During the Town Meeting, a dedication can include a presentation sharing highlights of Harriet's service to the Town along with pictures of her, possibly in her role as on the Select Board. Bodnar volunteered to contact Virginia Rundell (Town Archivist), for photos.

Andy Payne suggested including a post about the dedication in Lincoln Talk. The committee agreed to include an article in the Lincoln Squirrel. Ms. Glass added that there will be in article in the upcoming BOS newsletter.

**Blogs:** The sub-committee discussed possible content for the upcoming blogs. Ms. Glass asked for the dates of upcoming Finance Committee meetings. Mr. Payne explained that a meeting is scheduled on March 7 for the discussion of the lighting control system and another on March 15 in preparation for the Annual Town Meeting.

The committee discussed the timing of a public update about the School Building Project prior to Town Meeting and agreed to suggest adding a short presentation to the agenda at the start of the regularly scheduled SBC Meeting on March 16.
