ANNUAL BUDGET

The annual budget is the primary way that the School Committee and the Town supports the District's educational vision, and our strategic priorities are the primary consideration when building the proposed annual budget,

The budget then is more than just a financial instrument and requires on the part of the Committee, the staff and the community orderly and cooperative effort to ensure sound fiscal practices for achieving the educational goals and objectives of the school system.

Public school budgeting is regulated and controlled by state and federal legislation, state and federal regulations, the Town of Lincoln By-laws, Lincoln School Committee policies and Superintendent's directives. The operating budget for the school system will be prepared and presented in line with state policy and regulations and will be developed and refined in accordance with these same requirements.

The Superintendent will serve as budget officer, but portions of this responsibility may be delegated by the Superintendent to administrative staff members or their staff as they deem appropriate. The three general areas of responsibility for the Superintendent as budget officer will be budget preparation, budget presentation, and budget administration.
