Re Report on the School Safety and Security Advisory Committee

Date: March 12, 2014

The School Safety and Security Advisory Committee is composed of school, safety and community members to address concerns and procedures for prevention and for action during an emergency. Membership includes:

The Committee met on the following dates: October 15, 2013; November 12, 2013; January 7, 2014; February 11, 2014 and February 25, 2014. The next meeting is scheduled for March 20, 2014.

The Committee has discussed the following topics:

- increased security measures locking main entrance doors, enforcing visitor sign in procedures, use of identification tags, expansion of campus intercom systems, installation of cameras at entrances, upgrade of locks on Lincoln classroom doors;
- implementation of the ALICE program;
- preparation for an evacuation drill; and
- updating the Crisis Manual.

A focus for the group has been on planning for evacuation drills on each campus. The drills will be conducted using the principles of ALICE, and teachers and students will evacuate and

move away from the building. This will feel and look different from the fire drills that adults and students are familiar with. A.L.I.C.E. is an acronym that stands for:

ALERT:	Get the word out that a threat exists.		
LOCKDOWN:	Secure a place to stay as much as possible as a starting		
	point to buy time.		
INFORM:	Give constant, real-time information throughout the		
	building using all available technology.		
COUNTER:	This is a last resort used when individuals are unable to		
	escape. Countering may be as simple as creating a		
	distraction to allow opportunities to escape		
FACILITATE:	The goal is to move students out of the danger zone.		

It is a school safety program developed in 2000 to offer additional options to students and staff in dealing with an armed intruder situation. It is an approach to school crisis events that differ from the previous practice of lockdowns. The general idea is the adults and children will be encouraged to:

- 1. report a strange activity; take action and call 911; and use school-wide communication systems.
- 2. be aware of your surroundings.
- 3. escape and/or evacuate.
- 4. use whatever is at your disposal to stay safe.

The Lincoln Public Schools previously used a simple lockdown drill keeping the students and staff locked in a classroom away from the doors and windows. ALICE training adds some options to the situation. One option is to barricade the classroom door making it harder for the intruder to enter. Another option is for evacuation if the intruder has gone to a different part of the building. The planned evacuation drill will include all adults and children moving out of the building and away from the immediate area until safety officers indicate that is it safe to return.

Evacuation Drill Plan

Purposes of the Evacuation Drill:

- to familiarize safety officers (security forces, fire and police), administrators, faculty, staff, students, parents and community partners (Leap, Youth Center, Clubhouse, Recreation Department, Magic Garden) with the plan to evacuate all school buildings in the case of an emergency;
- to familiarize safety officers (security forces, fire and police), administrators, faculty, staff, parents and students with the principles of ALICE (alert, lockdown, inform, counter, evacuate) Training and how to evacuate the building in this way;
- to provide an opportunity to implement and assess the plan for emergency evacuation and develop strategies and interventions to improve in the case of a real emergency;
- to provide opportunities to collaborate with safety officers (security forces, fire and police) and community partners (Leap, Youth Center, Clubhouse, Recreation Department, Magic Garden) so that a shared understanding of how to act together in an emergency is established; and
- to provide a sense of calmness among the administrators, faculty, staff, students, parents and community partners that a plan is in place to ensure safety in the case of an emergency and it has been practiced.

Evacuation Plan Details

<u>Brief overview</u>: All faculty, students and staff will be informed via school intercom that the building will need to be evacuated and a specific area of the building will need to be avoided due to "an incident" (Brooks office and lobby, HMS Lobby, No Hartwell incident). All faculty and staff will bring everyone outside and away from the building. They will evacuate with the students they have. They should leave doors unlocked. Everyone should leave belongings in the school (bags, coats, backpacks, etc.). They should move toward the closest evacuation site. (Going out classroom doors is expected). Safety officers (fire, police) will meet them there and tell them when it is safe to return to the building. Student attendance is to be taken upon return to the building and sent to each school office.

- development of a survey for adults to provide feedback on the drill;
- finalizing the Crisis Guide; and
- continued discussion about locking the main entrances to the schools.
