

## SCHOOL ADMISSIONS

All minors of school age who actually reside in the Town of Lincoln shall be entitled to attend the Lincoln Public Schools, as well as certain children who do not reside in the Town of Lincoln but who are admitted under School Committee policies relating to nonresident students.	
The residence or domicile of the parent is the residence of the child. In cases where the mother and father are separated, the residence of the child is where the child lives. Where the court has granted legal custody of the child to either parent, the parent's legal residence is then the child's legal residence. Where a legal guardian has been appointed, the residence of the guardian is the legal residence of the child. Proof of residence or legal guardianship may be required by the school administration. Every student seeking admission to the Lincoln Public Schools for the first time must present a birth certificate or equivalent proof of age acceptable to the Principal and proof of vaccination and immunizations as required by the state and the School Committee. The Principal with teachers will determine the placement procedures for six-year-olds transferring from another school whose birthdays occur prior to October 1.	
In keeping with the law, all new entrants shall present a doctor's certificate providing evidence that they have had the required immunizations and physical examination unless they are transferring from another Massachusetts school. ## **PROOF OF RESIDENCY**

School Committee Policies JEC – School Admissions; JECA – Admission of Resident Students; JECB – Admission of Non-Resident Students; and JECBB – Enrollment of METCO Students address residency standards for children enrolling in the Lincoln Public Schools. Proof of residency may be required by the school administration.

In the event that a parent or guardian is requested to document residency the following forms of evidence are acceptable.

All applicants must submit <b>at least</b> one document From <b>each</b> of the following columns:

The residency policy does not apply to homeless students. Regulations from the McKinney-Vento Act shall apply.
