Citizens should be encouraged by the school staff to assist them in various aspects of the school program in which they can be helpful. In all situations where citizens assist in any aspect of the school program, the staff member in charge of the school, department, team, class, etc., shall have full authority over and responsibility for the activities of the citizen(s) helping.

Citizens may assist in clerical work, in supervising pupil functions, in demonstrating skills, assisting in some aspect of instruction, conducting electives or other school activities, giving educational talks, performing in the area of music, drama, dance, etc.

Persons assisting school personnel as outlined in this policy statement should demonstrate that they are qualified to perform such assistance either by virtue of training or experience or in some other way acceptable to the school principal. Persons assisting school personnel should have the appropriate medical tests before they begin their duties.
