DRAFT SCHOOL ADMISSIONS

In order to attend the Lincoln Public Schools, a student must reside in the Town of Lincoln or be admitted under School Committee policies relating to non-resident students.

The residence or domicile of the parent is the residence of the child. In cases where the parents are separated, the residence of the child is where the primary residence of the parents or legal guardians who have physical custody of the child reside. Proof of residence or legal guardianship or custody agreements may be required by the school administration.

Every student seeking admission to the Lincoln Public Schools for the first time must present a birth certificate or equivalent proof of age acceptable to the Principal and proof of vaccination and immunizations as required by the state and the School Committee. The Principal will determine the placement procedures for six-year-olds transferring from another school whose birthdays occur prior to October 1.

The residency requirements described above shall not apply to the following:

- students who are entitled to attend the Lincoln Public Schools under the McKinney-
 <u>Vento Homeless Assistance Act;</u>
- children of non-resident employees of the Lincoln Public Schools who meet the criteria established by School Committee Policy JFAB;
- students whose parents divorce and share physical custody, provided one parent remains a resident of Lincoln and the student resides 50 percent or more of the time with the parent who resides in Lincoln; and
- 4. METCO students from Boston who meet the criteria outlined by School Committee Policy JFABC, Inter-district Students (Enrollment of METCO Students),

MASC Policy JF – School Admissions Reads:

All children of school age who reside in the town will be eligible to attend the public schools, as well as certain children who do not reside in the town but who are admitted under School Committee policies relating to nonresident students or by specific action of the School Committee.

Advance registration for prospective kindergarten students will take place in the spring. Every student seeking admission to school for the first time must present a birth certificate or equivalent proof of age acceptable to the Principal and proof of vaccination and immunizations as required by the state and the School Committee. Proof of residency of legal guardianship may also be required by the school administration.

SCHOOL ADMISSIONS

All minors of school age who actually reside in the Town of Lincoln shall be entitled to attend the Lincoln Public Schools, as well as certain children who do not reside in the Town of Lincoln but who are admitted under School Committee policies relating to nonresident students.

A birth certificate and proof of residence or legal guardianship may be required by the school administration.

PROOF OF RESIDENCY

School Committee Policies JEC – School Admissions; JECA – Admission of Resident Students; JECB – Admission of Non-Resident Students; and JECBB – Enrollment of METCO Students address residency standards for children enrolling in the Lincoln Public Schools. Proof of residency may be required by the school administration.

In the event that a parent or guardian is requested to document residency the following forms of evidence are acceptable.

All applicants must submit at least one document From each of the following columns:

The residency policy does not apply to homeless students. Regulations from the McKinney-Vento Act shall apply.
