Subject: Request for Award – Hanscom Snow Removal Services

Background. The School Committee is responsible for snow plowing and removal on the Hanscom Campus; the Town's DPW provides those services on the Lincoln Campus. Typically, we include \$35,000 - \$50,000 in the budget for these services, with the precise expenditures depending on the number and nature of the snowfalls. The table below shows the snow removal expenditures for the past thirteen fiscal years:

The last competed contract for Hanscom snow removal expired at the end of the snow season in May, 2012.

Contracts for snow plowing services are exempt from the provisions of M.G.L Chapter 30B, which governs the procurement of supplies, services and real property in Massachusetts. Nevertheless, it is a longstanding policy of the administration and the School Committee to seek competition in the award of contracts where possible.

Prior bid process. The Business Office designed a process for competing these services in 2003, 2006 and 2009 which closely followed the provisions of M.G.L Chapter 30. After advertising in the *Lincoln Journal* and the *Central Register*, a pre-bid conference was

held. Local vendors who have performed well for us in the past were personally invited and provided with information about the upcoming competition. However, when the bids were opened for all three competitions, D&P Contracting was the only vendor who submitted a bid. D&P Contracting has provided snow removal services at Hanscom for over thirteen years.

FY13 through FY19 situation. In reviewing the procurement strategy for the FY13 snow removal service period, we realized that we could not prepare a scope of work which would be accurate for a three-year period. We recognized that we would not have a sufficiently-detailed understanding of the circulation patterns and snow removal needs for the Hanscom Schools for the next several years, until after the HPS project construction is complete. Accordingly, the administration decided to explore awarding a one-year contract to D&P Contracting on a sole–source basis, and requested a proposal. The School Committee subsequently approved awarding a one-year contract to D&P Contracting at an increase in price of 3%.

The one-year delay in the award of the Hanscom Middle School Replacement project meant that we were in the same situation in August 2013, with no clearer understanding of the snow-plowing needs on the Hanscom Campus for the next few years. The School Committee approved awarding a one-year contract for FY14 to D&P Contracting at no increase in price. The same situation existed for FY15; the School Committee approved an award to D&P Contracting with a three percent increase. The same situation existed in FY16, FY17 and FY18, and the School Committee approved an award to D & P Contracting each of the three years with no increase in rates. The School Committee approved contract awards to D&P Contracting with an increase in rates in FY19, and with no increase in FY20.

Current situation. We continue to believe that the long-term relationship with D&P Contracting on Hanscom has value, particularly in this time of pandemic. We once again requested a proposal from D&P Contracting.

Request for award. D&P Contracting provided the attached proposal for a one-year contract. These prices represent increases of 3.0-3.9% over the rates for services during the past year's performance period, with one exception.

The rate for the truck with sander is an increase of 96%. This increase was a topic of discussion during last year's snow season, and we advised D&P to propose an increase for this year. The new access road and complicated parking lot at the Hanscom Primary School does represent a significant increase in work. After consideration of the past rate history and reviewing the increased scope caused by the opening of the new HPS, these prices seem reasonable.

D&P Contracting continues to perform well. They are reliable and trustworthy, with a strong knowledge of the site and our expected performance standards. They are responsible, and the proposal they submitted, responsive.

In conclusion, the proposal they submitted is reasonable, and the administration recommends that the School Committee award a one-year contract for snow removal services at Hanscom to D&P Contracting. Funds are available in the FY21 budget to accomplish this proposed work.
